## Introduction

The **Level 2 Award in Asbestos Awareness** qualification helps employers to demonstrate their compliance with the Control of Asbestos Regulations, ensuring that their employees who may be liable to exposure to asbestos have received adequate training relating to the risks.

The aim of this qualification is to raise awareness of health risks associated with exposure to asbestos.

The awarding organisation for this qualification is ProQual AB. This qualification is regulated by the Office of Qualifications and Examinations Regulation (Ofqual) and the Council for the Curriculum Examinations and Assessment (CCEA) Regulation. The Regulated Qualifications Framework (RQF) includes those qualifications regulated by Ofqual and CCEA Regulation.

## Internal Quality Assurance
